
E. There are no unpaid claims or demands against the decedent or her estate. That the Department of Human Services furnished no federal or state benefits to the decedent.



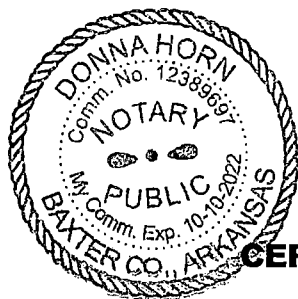

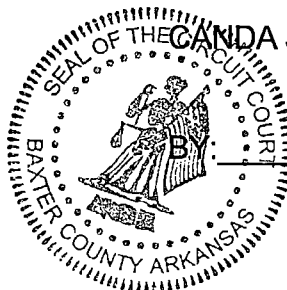
