

3. On or about March 15, 2021, the Trustee, R. Ray Fulmer, II, filed his Application for Approval of Attorneys' Fees and Reimbursement of Costs with this Court and no objections were filed within the time set forth in said Application.

4. On or about April 5, 2021, the United States Trustee filed comments with respect to the Application for Attorneys' Fees and and Reimbursement of Costs stating that the United States Trustee had no objection.

5. Pursuant to the Order of this Court, Ledbetter, Cogbill, Arnold & Harrison, LLP, as attorneys for the estate, are entitled to Five Thousand Seven Hundred Forty and 00/100 Dollars [\$5,740.00] in attorneys' fees and Reimbursement of Costs in the amount of Three Thousand Sixty-Seven and 37/100 Dollars, [\$3,067.37] and the Trustee, R. Ray Fulmer, II, is hereby authorized to make payment to said attorneys in these amounts from the assets of the estate.
