**STIPULATION REGARDING  
 DEADLINES FOR AMENDED  
 COMPLAINT AND RESPONSE**

1 WHEREAS, on June 4, 2019, Plaintiff BlackBerry Limited (“BlackBerry”)  
2 filed a First Amended Complaint (Dkt. 36);

3 WHEREAS, on June 25, 2019, Defendant Twitter, Inc. (“Twitter”) filed a  
4 Motion to Dismiss the First Amended Complaint (Dkt. 39);

5 WHEREAS, on October 2, 2019, the Court entered a Final Ruling on Twitter’s  
6 Motion to Dismiss (Dkt. 51);

7 WHEREAS, the Court provided BlackBerry with the option to file a Second  
8 Amended Complaint; and

9 WHEREAS, Twitter desires to extend the deadline to file an Answer to the First  
10 Amended Complaint in the event BlackBerry chooses not to file a Second Amended  
11 Complaint;

12 WHEREAS, BlackBerry is considering whether to file a Second Amended  
13 Complaint and desires to extend the deadline for such filing in conjunction with  
14 Twitter’s extension.

15 THEREFORE, IT IS HEREBY STIPULATED AND AGREED:

16 1. BlackBerry will file a Second Amended Complaint, if at all, no later than  
17 October 24, 2019;

18 2. Should BlackBerry decide not to file a Second Amended Complaint by  
19 October 24, 2019, Twitter’s Answer to the First Amended Complaint will be due on  
20 November 8, 2019.
