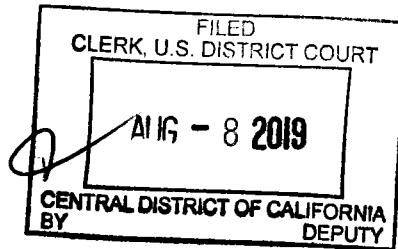

In regard to Blaricum CD Company, the complaint concerns three sound recordings for which,
as per agreement with Orchard/IODA, Orchard, not Blaricum CD Company, is responsible for
payment and reporting of mechanical royalties;

Second, the three recordings in question are not "pirate" or "bootleg" recordings as stated in
the complaint, but rather were licensed by Blaricum CD Company from rights holders for
various territories including the USA. (It should be noted that Nat King Cole – It's Only A Paper
Moon is a broadcast recording, not the original studio recording.)

For these reasons --- the sound recordings are not bootleg or pirate but rather licensed, and
responsibility for mechanical rights reporting and payment belong to Orchard --- Blaricum CD
Company should be removed as a defendant in this complaint.
