1 On December 18, 2023, the parties submitted a joint status report informing the
2 Court that there were no further updates on the Singapore Arbitration. (ECF No. 169.)
3 On December 20, 2023, the Court directed the parties to file another joint status report
4 regarding the Singapore Arbitration by February 19, 2024, and continued the
5 scheduled December 21, 2023 status conference to February 22, 2024. (ECF No. 171.)
6 The parties respectfully submit the following status report in compliance with the
7 Court's order.

8 Plaintiffs have been informed that the Singapore Arbitration Tribunal recently
9 submitted its final award to the Singapore International Arbitration Centre's Registrar
10 for review and approval. Plaintiffs understand that the Registrar's review and approval
11 process usually takes between 1–2 months. However, it may take longer depending
12 on the number of issues the Registrar identifies for comment. Once review and
13 approval is complete, the final award will be issued.

14 Based on this update, the parties respectfully request filing a joint status report
15 on March 18, 2024 and continuing the currently scheduled February 22, 2024 status
16 conference to March 21, 2024, or as the Court deems appropriate.
