2 TO ALL PARTIES AND THEIR ATTORNEYS OF RECORD:

3 PLEASE TAKE NOTICE that in light of Uber Technologies, Inc.’s (“Uber”) agreement
4 to arbitrate Mr. Levandowski’s claims to specifically enforce Uber’s indemnity obligations (*see*
5 ECF No. 43), Mr. Levandowski hereby withdraws his motion to compel arbitration (ECF No. 18).
6 The hearing previously set for April 30, 2020 at 10:00 a.m., in Courtroom 19 of this Court is also
7 withdrawn.

8 Mr. Levandowski disagrees with the statements and allegations contained in Uber’s
9 response to the motion to compel arbitration. Given that the parties have agreed on the
10 appropriate forum for these claims, he will proceed with his claims against Uber in arbitration as
11 agreed to by the parties and will respond to Uber’s allegations in the arbitration proceeding.
