NOTICE OF MOTION AND MOTION

TO ALL PARTIES AND THEIR COUNSEL OF RECORD:

PLEASE TAKE NOTICE that on July 17, 2020, at 10:00 a.m. (*see* ECF 79), or as soon thereafter as the matter may be heard, in the Courtroom of the Honorable Charles R. Breyer, located at 450 Golden Gate Avenue, San Francisco, CA 94102, Courtroom 6, 17th Floor, Pivotal Software, Inc. (“Pivotal”), Cynthia Gaylor, Egon Durban, Khozema Z. Shipchandler, Marcy S. Klevorn, Michael Dell, Paul Maritz, Robert Mee, and William D. Green (together with Pivotal, the “Pivotal Defendants”) will, and hereby do, move pursuant to Federal Rules of Civil Procedure 8, 9(b), and 12(b)(6) to dismiss the Consolidated Amended Complaint for Violations of the Federal Securities Laws (the “Complaint”) filed by Lead Plaintiffs Oklahoma City Employee Retirement System (“Oklahoma City”) and Police Retirement System of St. Louis on February 11, 2020.
