10	Non-Privileged Documents (Dkt. No. 389-5). The Clerk of the Court shall maintain the	
11	"sealed/unredacted" version of this document. Only this Court, court personnel, and parties to	
12	this case may inspect the records sealed by this Order.	
13	Defendants have stated that they do not seek to maintain under seal Lead Plaintiff's	
14	Motion to Compel Review and Production of Non-Privileged Documents (the "Motion to	
15	Compel") (Dkt. No. 389-3). Accordingly, the Administrative Motion is DENIED as to the	
16	Motion to Compel.
