**PLAINTIFFS' MOTION FOR PRELIMINARY INJUNCTION AND TEMPORARY
RESTRAINING ORDER AGAINST ALIGN TECHNOLOGY INC.
PROSECUTING A DUPLICATIVE ACTION IN THE
