A system to enable appearance comparison, the system comprising:</p>	<p>Regardless of whether the preamble of claim 1 is limiting, the Camera feature of the Facebook Messenger Application for Mobile Devices (“Messenger App”) is a system that enables the comparison of appearances. The Camera feature captured the images below.
