Chris:

Our position is that the total number of pages for post-trial briefs cannot exceed 170 pages. The Court was very clear about this in January. If you want to increase the size of your opening brief, we are okay with that as long as you reduce the size of your reply brief by the same amount of pages. We have 70 pages for our answering brief and are not seeking additional pages. We are not prepared to agree to increase the number of pages for plaintiff, which already has 100 pages in total -- 30 more than defendant. So, if you want to do an 80-page opening brief, your reply should be 20 pages; if you want to do a 75-page opening brief, your reply can be 25 pages. Should you seek a page extension from the Court, please attach this email string to your motion.
