**Count 2 Poss Firearm During Crime of Violence** Sentenced to 60 month(s) incarceration, 3 year(s) supervised release, \$100.00 VVCA, VVCA Due Date within 1 year of release.

**Count 3 Carry Pistol W/O Lic -Outside Home/Business** Sentenced to 24 month(s) incarceration, 3 year(s) supervised release, \$100.00 VVCA, VVCA Due Date within 1 year of release.

- Defendant shall receive credit for time served.
- Counts 1&2 to run consecutive to each count.
- Count 3 to run concurrent with Count 1&2.
- Supervised Release to run concurrent with each count.
