If it is not, please check with the Clerk in the courtroom before court begins or with the Pretrial Services Agency in Room C-301, or with a Clerk at the Information Window in the lobby of the courthouse to find out if your case will be handled in a different courtroom.

If Court is closed due to an emergency, you are obligated to return to Court the next business day at the time you were originally scheduled to appear.

If you fail to appear for sentencing, it may continue in your absence.

You remain under previously imposed conditions of release until further Order of the Court.
