Dear Ms. Bose, Judge Cintron, and Judge Brandwein:

Attached for filing are public and confidential versions of the Answering Testimony of Anadarko Petroleum Corporation and Tesoro Alaska Company (“Anadarko/Tesoro”), originally filed on June 27, 2011. This Answering Testimony is comprised of exhibits AT-22 through AT-213. Anadarko/Tesoro originally filed this testimony and accompanying exhibits entirely under seal because they contained information designated by the TAPS Carriers as confidential or highly confidential under the protective order in these proceedings.

For the portions of this testimony concerning cost-of-service issues, Anadarko/Tesoro and the Carriers have resolved all confidentiality issues. However, because the participants’ agreement-in-principle concerning the depreciation/life of line issue has rendered a hearing on this issue unnecessary, Anadarko/Tesoro decided not to contest at this time the Carriers’ confidentiality

designations on depreciation/life-of-line portions of this testimony. Rather, for testimony and exhibits pertaining to the depreciation/life-of-line issue, Anadarko/Tesoro is reserving all rights to challenge the Carriers' confidentiality designations should this become necessary at any time, and for any purpose, in the future.

The public versions of this testimony and associated exhibits contain redactions to protect information that the Carriers have designated as confidential, highly confidential, or CEII, and that Anadarko/Tesoro have elected not to challenge at this time, as discussed above.
