
- 1. The Ward was repeatedly arrested in 2021. See attached.
- The Ward has been in custody at Turner Guilford Knight Correctional Center for most of 2021 and all of 2022. The Co-Guardians expect him to be released on April 28, 2022.
- 3. The facility will not provide a Physician's Report.
- Given his incarceration for most of 2021, and his continued incarceration in 2022, Petitioners cannot file a Physician's Report with the 2022 Annual Plan.
