ORDER NO. 3: GRANTING RESPONDENTS' UNOPPOSED MOTION FOR AN EXTENSION OF TIME FOR DOMESTIC RESPONDENTS TO RESPOND TO THE AMENDED COMPLAINT AND NOTICE OF INVESTIGATION

(September 22, 2017)


On September 21, 2017, Respondents Pool & Spa Enclosures, LLC, Poolandspa.com, Alukov HZ Spol. S.R.O., Alukov, Spol. S.R.O., and Inter Pool Cover Team (collectively, "Respondents") moved (1069-001) to extend the date by which Pool & Spa Enclosures, LLC and Poolandspa.com (collectively, "the Domestic Respondents") must file their answers to the Amended Complaint and Notice of Investigation to October 6, 2017. Respondents request the extension to consolidate the dates by which the non-U.S. Respondents and the Domestic Respondents must respond to the Amended Complaint and Notice of Investigation. They explain that "[a]ll five Respondents are represented by the same counsel" and that the short extension will streamline Respondents' efforts in the preparation of their responses. (Mot. at 2.)

Neither Complainant nor the Commission Investigative Staff opposes Respondents' motion.

(*Id.* at 1-2.)


Good cause having been shown and there being no opposition, the motion (1069-001) is hereby granted.
