337 AND RECOMMENDED DETERMINATION ON REMEDY AND BOND



On this date, the undersigned issued an initial determination on violation of section 337 and a recommended determination on remedy and bond in the above-referenced investigation.

It is held that a violation of section 337 of the Tariff Act of 1930, as amended, has been found in the importation into the United States, the sale for importation, or the sale within the United States after importation of certain electrical connectors, components thereof, and products containing the same with respect to U.S. Patent No. 7,004,766 as to Respondents Robert Bosch LLC., Robert Bosch, Sistemas Automatrices, S.A. de C.V., and Foxconn Interconnect Technology, Ltd. There is no violation of section 337 of the Tariff Act of 1930, as amended, as to the remaining Respondents.


