TO FILE JOINT PROPOSED PROCEDURAL SCHEDULE**


(August 20, 2018)

On August 17, 2018, Complainant Walbro, LLC, Respondents Amazon, Inc., Frictionless World, LLC, Northern Tool & Equipment Co., Inc., Tillotson, Walmart Inc. and Zhejiang Ruixing Carburetor Manufacturing Co., Ltd., and the Commission Investigative Staff (collectively, "the Parties") moved (1123-006) for an extension of time to file the joint proposed procedural schedule.

The Parties state that they have exchanged a series of draft schedules and have met and conferred three times in an attempt to prepare a Joint Proposed Procedural Schedule for filing on Friday, August 17, 2018. (Mot. at 1.) The Parties submit that they are near completion of a joint proposed procedural schedule, but require additional discussions to arrive at a final proposal. (*Id.*) The Parties therefore request that they be permitted to file their joint proposed procedural schedule on Monday, August 20, 2018. (*Id.*)

Good cause having been shown and there being no opposition, the joint motion (1123-006) is hereby granted.
