("LCI"). On July 3, 2019, LCI opposed the motion. The Commission Investigative Staff filed a response in support of the motion.

Having reviewed the pleadings and arguments contained therein, the undersigned finds that Walbro has not demonstrated the requisite "good cause" for amending the Complaint and Notice of Investigation, especially given the advanced stage of this Investigation. Accordingly, Walbro's motion (1123-052) is hereby denied.
