## NOTICE OF A COMMISSION DETERMINATION NOT TO REVIEW AN INITIAL DETERMINATION EXTENDING THE TARGET DATE

**SUMMARY**: Notice is hereby given that the U.S. International Trade Commission has determined not to review the presiding administrative law judge's ("ALJ") initial determination ("ID") (Order No. 59) extending the target date for completion of the above-captioned investigation to April 19, 2023.

SUPPLEMENTARY INFORMATION: The Commission instituted this investigation on August 18, 2021, based on a complaint filed on behalf of Masimo Corporation and Cercacor Laboratories, Inc., both of Irvine, CA. 86 FR 46275 (Aug. 18, 2021). The complaint, as amended, alleges violations of section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, based upon the importation into the United States, the sale for importation, and the sale within the United States after importation of certain light-based physiological measurement devices and components thereof by reason of infringement of certain claims of U.S. Patent Nos. 10,912,501; 10,912,502; 10,945,648; 10,687,745; and 7,761,127. *Id.* The amended complaint further alleges that an industry in the United States exists and/or is in the process of being established as required by the applicable Federal Statute. *Id.* The notice of investigation named Apple Inc. of Cupertino, CA as a respondent. *Id.* at 46276. The Office of Unfair Import Investigations is not participating in this investigation. *Id.* 



On October 24, 2022, the ALJ issued the subject ID (Order No. 59) extending the target date by approximately seven weeks to April 19, 2023. Based on this target date, the deadline for issuing the final ID is December 19, 2022. The ID states that good cause exists to extend the target date because of the complexity of this investigation, the consideration of post-hearing motions in this investigation, and the ALJ's obligations in other investigations. *See* Order No. 59 at 1-2. No petitions for review were filed.

The Commission has determined not to review the subject ID. The target date is now April 19, 2023.

The Commission vote for this determination took place on November 10, 2022.

The authority for the Commission's determination is contained in section 337 of the Tariff Act of 1930, as amended, 19 U.S.C. 1337, and in Part 210 of the Commission's Rules of Practice and Procedure, 19 CFR Part 210.
