On September 18, 2023, Proposed Respondents Lenovo (United States) Inc. and Motorola Mobility LLC (collectively, "Lenovo") submitted a letter requesting, *inter alia*, that the Commission use the Early Disposition Program to address an allegation of lack of standing and/or inability to satisfy the technical prong of the domestic industry analysis.

The Commission has determined not to use the Early Disposition Program pursuant to 19 C.F.R. § 210.10(b)(3) for these investigations. It does not appear from the request that resolution of the standing issue would be dispositive with respect to all (rather than just some) of the asserted patents, and other issues raised may also be too complex to be decided within 100 days of institution.

Accordingly, the Commission hereby DENIES the Request.
