**ORDER NO. 5: GRANTING RESPONDENTS AMKOR AND AVNET'S
UNOPPOSED MOTION FOR LEAVE TO PARTICIPATE IN A
FIRST SETTLEMENT CONFERENCE BY TELEPHONE, TO THE
EXTENT NECESSARY**

(April 17, 2012)

On April 6, 2012, Amkor Technology, Inc. ("Amkor") and Avnet, Inc. ("Avnet") (collectively "the Moving Parties") filed a motion for leave to participate in the first settlement conference with Complainant Knowles Electronics LLC ("Knowles") by telephone to the extent necessary. (Motion Docket No. 825-001.)

The Moving Parties state that representatives of Knowles and Respondent Analog Devices, Inc. ("Analog") scheduled their first settlement conference for Monday, April 9, 2012 in Washington, D.C. The Moving Parties state that representatives of Knowles and Analog with settlement authority will participate in person, as required by Ground Rule 2 and that Analog's representative will also have negotiating authority for Amkor and Avnet, who are in this matter solely by reason of their relationship with Analog. The Moving Parties argue that it will impose a significant burden on them to travel across the country to participate in a conference in which, in

reality given their relationship with Analog, they would be primarily passive observers.

Good cause having been shown, Motion No. 825-001 is hereby GRANTED.


