SCHEDULE TO EXTEND THE DEADLINE FOR THE SECOND
SETTLEMENT CONFERENCE AND TO PERMIT RESPONDENTS
AMKOR TECHNOLOGY, INC. AND AVNET, INC. TO
PARTICIPATE BY TELECONFERENCE**
(June 15, 2012)

On June 13, 2012, the parties in this Investigation filed a joint motion to amend the Procedural Schedule established in Order No. 4 to extend the deadline to hold the Second Settlement Conference to June 26, 2012. (Motion Docket No. 825-03) This is the only date in the Procedural Schedule the parties wish to change, and the modified deadline that the parties are jointly seeking will not affect any other dates in the Procedural Schedule. Respondents Analog Devices, Inc., Amkor Technology, Inc. and Avnet, Inc. also moved for permission to attend the Second Settlement Conference by teleconference as needed, to which Complainant Knowles Electronics, LLC does not oppose.

Good cause having been shown, Motion Docket No. 825-03 is hereby GRANTED. The deadline for the Second Settlement Conference is now June 26, 2012. Respondents Analog Devices, Inc., Amkor Technology, Inc. and Avnet, Inc. may attend the Second Settlement Conference by teleconference as needed.
