Respondents certify that they met and conferred with Complainant Knowles Electronics, LLC ("Knowles"), regarding the subject of this motion and Knowles does not oppose.

Under the current Procedural Schedule, the parties' initial post-hearing briefs and final exhibit lists are due on October 18 and the parties' reply post-hearing briefs are due on November 1. This additional time will enable the parties to submit clearer and more concise post-hearing briefs. The requested four-day extension is also commensurate with the four days by which the start of the hearing was postponed. (*See* Order No. 7.) For good cause shown and there being no opposition, Respondents respectfully request that the deadlines for the parties' post-hearing submissions be
