COMPLAINANT'S APPLICATION FOR RECOMMENDATION TO THE UNITED STATES DISTRICT COURT FOR THE DISTRICT OF MASSACHUSETTS TO ISSUE AN ORDER/COMMISSION REQUIRING DEPOSITIONS OF EMPLOYEES OF RESPONDENT PANASONIC CORPORATION IN OSAKA, JAPAN

Pursuant to 19 C.F.R. § 210.26 and 210.28, Complainant Graphics Properties Holdings, Inc. ("GPH") respectfully applies to the Administrative Law Judge ("ALJ") for a Recommendation that the United States District Court for the District of Massachusetts issue an order requiring the depositions of certain employees of Respondent Panasonic Corporation (hereinafter, "Panasonic"), located at 1006 Oaza Kadoma-shi, Kadoma 571-8501, Osaka, Japan. *See Ex. 1*

GPH noticed Panasonic Corporation for deposition in this Investigation on July 17, 2013. *See* Ex. 2. GPH applied for a first Order to Take Depositions in Japan on August 8, 2013, for a set of Panasonic witnesses. Panasonic was unable to make available certain witnesses relating to Panasonic semiconductors during the initial deposition window, and GPH and Panasonic agreed to find other available dates. Panasonic subsequently agreed to make an additional witness available on September 24 and 25 in Osaka, Japan, to testify on the remaining topics related to Panasonic semiconductors. The District Court order GPH seeks is directed to deposition testimony from the following Panasonic employee, who has volunteered to offer testimony at the United States Consulate in Osaka, Japan:

Shinichi Marui

GPH has reserved rooms at the Consulate General of the United States of America, Osaka-Kobe for these depositions beginning on or about September 24, 2013, and continuing until on or about September 25, 2013. *See* Ex. 3.

Pursuant to Consulate rules, the deposition testimony sought by GPH is unavailable absent an order from a United States District Court that the depositions take place at the United States Consulate in Osaka, Japan, or an order compelling deposition testimony at a location outside of Japan, such as the United States. In the past, the International Trade Commission has issued, and the United States District Court for the District of Massachusetts has acted in accordance with, recommendations similar to the proposed Recommendation attached to this application. See e.g., Certain Consumer Electronics and Display Devices and Products Containing Same, Inv. No. 337-TA-836, Order No. 10, (granting complainant's motion seeking issuance of a recommendation that the District Court for the District of Massachusetts issue orders to obtain deposition testimony from respondents in Japan).

GPH therefore respectfully requests that the ALJ issue a Recommendation to the United States District Court for the District of Massachusetts to issue an order requiring the depositions of the above-named Panasonic employees. Panasonic does not oppose this request. Staff, AmTran Technology Co., Ltd., AmTran Logistics, Inc., Toshiba Corporation, Toshiba America, Inc., Toshiba America Information Systems, Inc. and VIZIO, Inc. have not stated their position for this request. GPH further requests that such a Recommendation be issued on an expedited basis given the relevance and importance of the information at issue and the limited time to obtain the necessary order from the United States District Court for

the District of Massachusetts. To ease the burden on the ALJ, a proposed Recommendation is attached for consideration. *See* Ex. 4.



- 5. "Asserted Patents" means, collectively, U.S. Patent Nos. 5,717,881 ("the '881 Patent"), 6,650,327 ("the '327 Patent"), and 8,144,158 ("the '158 Patent").
- 6. "Respondents" means Panasonic Corporation, Panasonic Corporation of North America, Toshiba Corporation, Toshiba America, Inc., Toshiba America Information Systems, Inc., Vizio, Inc., AmTran Logistics, Inc., and AmTran Technology Co., Ltd.
- 7. "Third Party" or "Third Parties" means any person or entity other than GPH or Respondents.
