1. Plaintiff, Kathleen Jones, is a resident of the City of Livonia, County of Wayne and State of Michigan.

2. Defendant, Thermo-Fisher Scientific Inc., (hereinafter “Thermo-Fisher”) is a foreign profit corporation, authorized to do business in the State of Michigan whose resident agent is Capitol Corporate Services, Inc., and whose registered mailing address is 186 N. Main Street, 2nd Floor, Suite 1, Plymouth, MI 48170.

3. The events producing the original injury occurred in the County of Wayne and State of Michigan.
