**Stipulation to Lift Stay of Judgment
and Release Order**

(First Request)

16 IT IS HEREBY STIPULATED AND AGREED, by and between Jason M. Frierson,
17 United States Attorney, and Jim W. Fang, Assistant United States Attorney, counsel for the
18 United States of America, and Rene L. Valladares, Federal Public Defender, and Joy Chen,
19 Assistant Federal Public Defender, counsel for Thomas Eric Conmy, that the stay of Mr.
20 Conmy's judgment and release order be lifted.

21 This Stipulation is entered into for the following reasons:

22 1. On March 26, 2024, this Court reduced Mr. Conmy's life sentence to a sentence
23 of time served. ECF No. 216. The Court stayed imposition of the amended judgment for 30
24 days in order to allow the United States Probation Office to conduct a prerelease investigation.
25 *Id.*

1 2. As of the date of this filing, the USPO's prerelease investigation has
2 concluded. The USPO in the Central District of California has approved Mr. Conmy's sister's
3 residence as an appropriate residence. Transfer supervision in the Central District of
4 California has been approved.

5 3. The parties thus respectfully request that the Court lift the previously imposed
6 stay and enter its amended judgment/release order at this time.

7 This is the first request filed herein.


