**STIPULATION TO CONTINUE
REVOCATION HEARING**
(First Request)

17 IT IS HEREBY STIPULATED AND AGREED, by and between Jason M. Frierson,
18 United States Attorney, and Allison Reese, Assistant United States Attorney, counsel for the
19 United States of America, and Rene L. Valladares, Federal Public Defender, and Joy Chen,
20 Assistant Federal Public Defender, counsel for Asharon Bravo, that the Revocation Hearing
21 currently scheduled on October 27, 2023, be vacated and continued to a date and time
22 convenient to the Court, but no sooner than one hundred and twenty (120) days.

23 This Stipulation is entered into for the following reasons:

24 1. The parties have reached a tentative resolution of this matter. The parties seek
25 to continue the matter by four months to allow Ms. Bravo to come into compliance with the
26 terms of her supervised release. If she is able to do so and does not sustain any additional

1 violations, the Government and the United States Probation Office will recommend dismissal
2 of the instant petition to revoke supervised release.

3 2. Ms. Bravo is out of custody and does not oppose the continuance.

4 3. The parties agree to the continuance.

5 This is the first request for a continuance of the revocation hearing.
