STIPULATION OF SETTLEMENT

- 5. Upon full payment by Defendant in accordance with the terms of this stipulation of settlement, Plaintiff shall file a notice of discontinuance or a satisfaction of judgment, if applicable, with the Court.
- 6. In the event the court requires that a stipulation of discontinuance be filed regardless of the fact full payment has not been made in accordance with the terms of settlement, then Defendant consents to have
