

issue, and file separate judgments; and it is further,


ORDERED, that the order in which the parties open and close shall be determined by the court,

contained therein to the clerk of Kings County; and it is further,


\*\*ORDERED, that the plaintiff(s) in index # 70235/18 shall forthwith file an RJI together
