

4. Date by which defendants are to serve responses to plaintiffs' interrogatories and document requests and any objections to plaintiffs' interrogatory responses. June 4, 2021
5. Date by which defendants are to serve supplemental interrogatories October 1, 2021
6. Date by which plaintiffs are to serve supplemental interrogatories. November 1, 2021
7. Date by which defendants are to serve responses to plaintiffs' supplemental interrogatories. August 6, 2021
8. Date by which plaintiffs are to serve responses to defendants' supplemental interrogatories. July 6, 2021
