4. Lot 3 cannot be accessed through Lot 4 because, to the extent a narrow hiking path exists, even walking access is prevented by challenging terrain and overgrown trees and shrubbery. Moreover, even on Lot 4, the Defendants have installed chains, gates, and signage stating that trespassers will be shot. Annexed hereto as Exhibit B is a photograph that I captured at the premises at Bassler Road and Lot 4. The photograph fairly and accurately depicts the scene depicted.

5. Due to the foregoing, Petitioner respectfully requests access to the abutting lot (known as Lot #12) to conduct the eviction.
