- DEFENDANT is directed to bring copies and fax receipts of all documents submitted to the lender at the next court conference.
- PLAINTIFF is directed to provide DEFENDANT with a direct telephone and fax number to the lender's loss mitigation representative and bank attorney.
- PLAINTIFF is directed to review defendant homeowner's application and advise if additional information is needed by \_\_\_\_\_.
- PLAINTIFF is directed to advise defendant if modification is granted or denied by \_\_\_\_\_.
- PLAINTIFF is directed to provide a written report stating, with specificity, all programs available and all good- faith efforts undertaken to resolve this matter by the next court conference.
- The court directs PLAINTIFF to have the lender's representative, authorized to settle, as follows:
  - Present in Court on the next court date.
  - Available to the court by DIRECT telephone line.
