ORDER  
Decision on Motion to Withdraw  
*37 C.F.R. § 42.10*

Counsel for Patent Owner has filed a motion to withdraw in this proceeding. Paper 25. Patent Owner has filed a new power of attorney appointing Brenton R. Babcock as lead counsel and Ted M.
