A Final Written Decision issued on March 31, 2017. Paper 86. On April 30, 2019, the Federal Circuit affirmed the Final Written Decision, and the mandate issued on August 7, 2019. *See* Paper 90, 3. No writ of certiorari was timely filed with the Supreme Court. *Id*.

On October 2, 2019, Patent Owner filed an unopposed Motion to Expunge Paper 34 and Exhibits 2143–2151, 2154, and 2156–2158 from the record pursuant to 37 C.F.R. § 42.56. Paper 90. Paper 34 and Exhibits 2143–2151, 2154, and 2156–2158 contain Patent Owner's confidential information and are sealed. *See* Papers 33, 84.

Rule 42.56 provides "after final judgement in a trial, a party may file a motion to expunge confidential information from the record." Paper 34 is a Motion for Additional Discovery, and a version of the Motion for Additional Discovery with the confidential information redacted appears in the public record as Paper 32. Our Final Written Decision did not rely upon Exhibits 2143–2151, 2154, and 2156–2158. Under these circumstances, Patent Owner's Motion to Expunge is *granted*.

ORDER

Accordingly, it is:

ORDERED that Patent Owner's Motion to Expunge (Paper 90) is *granted*; and

FURTHER ORDERED that Paper 34 and Exhibits 2143–2151, 2154, and 2156–2158 shall be expunged from the record.
