MOTION TO WITHDRAW BY PATENT OWNER'S ADDITIONAL BACK-UP COUNSEL



I. Statement of Precise Relief Requested

Pursuant to 37 C.F.R. § 42.10, Patent Owner Nike, Inc.'s ("NIKE's") backup counsel J. Pieter van Es, Thomas K. Pratt, H. Wayne Porter, and Joseph M. Skerpon respectfully request that the Patent Trial and Appeal Board ("the Board") authorize their withdrawal from this proceeding.

II. Statement of Facts Showing Good Cause for the Relief Requested
