- 4. Whether claims 1, 11, 12, and 22 are anticipated by Lim.
- 5. Whether claims 1, 11, 12, and 22 are anticipated by ESX.
- 6. Whether claims 1, 11, 12, and 22 are anticipated by ESX.
- 7. Whether claims 1 and 12 are anticipated by Suzaki.
- 8. Whether 11 and 22 are rendered obvious over Suzaki in view of Wang.
- 9. Whether Symantec's Motion to Amend is deficient.
- 10. Whether substitute claim 31 is anticipated by Lim.
- 11. Whether substitute claims 32, 33, and 34 are rendered obvious over Lim in view of Li.
