Joint Motions to Expunge Confidential Information
37 C.F.R. § 42.56

Amneal and Supernus filed a joint motion to expunge Supernus's confidential information from each of the above-referenced proceedings. *E.g.*, IPR2013-00368, Paper 95 ("Mot.").

In particular, the parties seek expungement of Supernus's Patent Owner Response (unredacted version),¹ Supernus's Opposition to Amneal's Motion to Exclude Evidence (unredacted version),² and Exhibits 2016, 2017, 2027, 2028, 2029, 2032, 2033, 2034, 2036, 2037, 2039, 2040, 2041, 2042, 2045, 2046, 2048, 2049, 2050, 2059, 2060, 2063, 2064, 2102, 2146, 2147, 2148, 2149, 2150, 2151, 2152, 2153, 2154, 2155, 2157, 2186, 2193, 2195, 2203, 2207, 1046, 1047, 1048, 1053, 1054, 1055, 1066, 1067, 1071, 1075, 1076, 1077, 1078, 1079, 1080, 1081, 1082, 1083, 1084, 1088, 1096, 1097, 1098, 1106, and 1116. Mot. 2–5 (table). Each of these documents contains Supernus information designated as confidential. *Id.* The parties indicate that of these documents, only the Patent Owner Response, the Opposition to the Motion to Exclude Evidence, and Exhibits 2016, 2193, and 1066 were cited in the final written decisions, but that the cited passages are visible in redacted versions of these documents. *Id.* at 5–6.

Upon consideration of the motion and review of the documents in question, each motion is granted in full. The above-listed documents shall be expunged from the respective record of each proceeding.

It is so ordered.
