Petitioner Under Armour, Inc. ("Petitioner") requests a refund of postinstitution fees in the amount of \$14,000.00.

On February 5, 2015, Petitioner filed a Petition for Inter Partes review of U.S. Patent No. 7,292,867. As required by 37 C.F.R. § 42.15(a), Petitioner deposited \$23,000.00 with the U.S. Patent and Trademark Office ("USPTO") at the time of filing the Petition to cover associated fees. Petitioner's payment consisted of \$9,000.00 in fees associated with the request for Inter Partes review, and a further \$14,000.00 in post-institution fees.

On July 16, 2015, the Board issued a Decision Denying Institution of Inter Partes Review (Paper 9). Petitioner filed a Request for Rehearing (Paper 10), which the Board denied in an Order dated September 30, 2015 (Paper 11). Inter Partes review was thus not instituted. Accordingly, Petitioner requests a refund of the post-institution fees paid to the USPTO in connection with this proceeding, totaling \$14,000.00, to be paid to deposit account number 506499 (referencing Attorney Docket No.78678.0022).
