Based on the facts set forth in the motions and the accompanying affidavits from Mr. Ishmael, we conclude that Mr. Ishmael has sufficient legal and technical qualifications to represent Patent Owner in these cases, that Mr. Ishmael has demonstrated the necessary familiarity with the subject matter of these cases, and that there is a need for Patent Owner have counsel with experience as a litigation attorney in patent matters involved in these cases. FURTHER ORDERED that Patent Owner continue to have a registered practitioner as lead counsel in these cases;

FURTHER ORDERED that Mr. Ishmael comply with the Office Patent Trial Practice Guide and the Board's Rules of Practice for Trials, as
