Pursuant to the Scheduling Order, dated February 1, 2016 (Paper No. 10), and Notice of Stipulation to Extend Due Dates 2, 4, and 5, filed June 28, 2016 (Paper No. 22), Petitioners LG Electronics, Inc. and LG Electronics U.S.A., Inc. (“Petitioner”) respectfully request oral argument on the issues set forth below. The Oral Hearing is scheduled to be held on October 6, 2016. Paper No. 28.

Petitioner submits that 45 minutes of oral argument per side will be adequate to present arguments on the issues listed below.

Pursuant to 37 C.F.R. § 42.70(a), Petitioner identifies the following issues as among those to be argued:

1. The unpatentability of claims 1, 2, and 5-9 under 35 U.S.C. § 103(a) over Akanuma (Ex. 1002) and the Admitted Prior Art (“APA”) (Ex. 1001).
2. The unpatentability of claims 1, 2, and 5-9 under 35 U.S.C. § 103(a) over Akanuma, the APA, and Ikegame (Ex. 1005).
3. The unpatentability of claims 3 and 4 under 35 U.S.C. § 103(a) over Akanuma, the APA, and Wakabayashi (Ex. 1007).

4. The unpatentability of claims 3 and 4 under 35 U.S.C. § 103(a) over Akanuma, the APA, Ikegame, and Wakabayashi.
5. All arguments and issues in the Petition and cited exhibits.
6. All arguments and issues in Patent Owner's Response and cited exhibits.
7. All arguments and issues in Petitioner's Reply to Patent Owner's Response and cited exhibits.

Petitioner requests the ability to use audio/visual equipment to display demonstrative exhibits and evidence of record, including the use of a projector and screen for a PowerPoint presentation and other visual display.
