ORDER
Conduct of the Proceeding
37 C.F.R. § 42.5(a)

On October 24, 2017, we issued an Order expunging certain papers and exhibits, and ordering Patent Owner to re-file those exhibits with unique exhibit numbers. Paper 44, 3–4. Also we authorized Petitioner to re-file a corrected Reply with no changes other than correcting citations to use the new exhibit numbers used by Patent Owner. *Id.* at 4.

On October 30, 2017, Patent Owner filed Exhibits 2010 to 2013 in accordance with our Order.

On November 2, 2017, Petitioner notified the Board by email that, although our Order authorized it to file a corrected Reply referring to the new exhibit numbers used by Patent Owner, other documents filed by Petitioner—Exhibit 1022, Paper 39, and Paper 46—still referred to now obsolete exhibit numbers. Petitioner requests that we expunge Exhibit 1022, Paper 39, and Paper 46, and we authorize Petitioner to re-file those documents with no changes other than correcting citations to refer to the new exhibit numbers of the exhibits re-filed by Patent Owner on October 30, 2017.

In order to maintain a clear record, we *grant* Petitioner’s request.

ORDER

Accordingly, it is:

ORDERED that, pursuant to 37 C.F.R. § 42.7(a), Exhibit 1022, Paper 39, and Paper 46 are expunged; and

FURTHER ORDERED that Petitioner is authorized to re-file new versions of Exhibit 1022, Paper 39, and Paper 46 with no changes other than correcting citations to refer to the new exhibit numbers of the exhibits re-filed by Patent Owner on October 30, 2017.
