ORDER

Granting Petitioner's Motion for Admission *Pro Hac Vice* of

Petitioner moves for *pro hac vice* admission of Mr. Steven G. Hill. *See e.g.*, IPR2015-01079, Paper 21.² Petitioner provides affidavits from Mr. Hill in support of its motions. *See e.g.*, IPR2015-01079, Ex. 1015. Patent Owner has not filed an opposition to Petitioner's motions.

Based on the facts set forth in the motions and the accompanying affidavits from Mr. Hill, we conclude that Mr. Hill has sufficient legal and technical qualifications to represent Petitioner in these cases, that Mr. Hill has demonstrated the necessary familiarity with the subject matter of these cases, and that there is a need for Petitioner have counsel with experience as a litigation attorney in patent matters involved in these cases. Accordingly, Petitioner has established good cause for Mr. Hill's *pro hac vice* admission. Mr. Hill will be permitted to appear *pro hac vice* in these cases as back-up counsel only. *See* 37 C.F.R. § 42.10(c).

In consideration of the foregoing, it is hereby:

ORDERED that Petitioner's motions for *pro hac vice* admission of Mr. Steven G. Hill are *granted*, and Mr. Hill is authorized to represent Petitioner as back-up counsel in these cases;

FURTHER ORDERED that Petitioner continue to have a registered practitioner as lead counsel in these cases;

FURTHER ORDERED that Mr. Hill comply with the Office Patent Trial Practice Guide and the Board's Rules of Practice for Trials, as set forth in Title 37, Part 42 of the Code of Federal Regulations; and
