Statement of Facts

Petitioner wishes to continue using Mr. Khadpe as counsel in this proceeding. Additionally, Mr. Khadpe has previously represented Alarm.com in other patent infringement litigations. Therefore, Petitioner respectfully submits that there is good cause for the Board to recognize Mr. Khadpe as counsel *pro hac vice* during this proceeding.
