- 3. Issues raised in the Petition, Patent Owner's Preliminary Response, Patent Owner's Response, Patent Owner's Contingent Motion to Amend and corresponding Oppositions and Replies, Petitioner's Reply, Patent Owner's Sur-Reply, and any Motion to Exclude, Motion to Strike, or Motion for Observation on Cross Examination and corresponding Oppositions and Replies (if filed);

- Any issues specified by Patent Owner Vedanti Systems Limited in its Request for Oral Argument;
- 5. Rebuttal to Patent Owner's presentation on all matters;
- 6. Any other outstanding motions and pleadings, and other issues that

the Board deems necessary for issuing a Final Written Decision.
