Cher Chris,

Unfortunately, that is the one they developed for us. Initially we were paying \$18,000 each, as you say MAD!!!! As you make more of them to use in various centers the price goes down, not much but until you are buying many of them they have you where they want you. We worked with them in the development and you remember that one we brought for the animal and human cases, and that is the one they will be selling.

They are trying to recapture their development costs.

I have not found other alternatives. Some companies make their own for use with their stents.

Good luck. By the way, ATS Medical deal was completed Sep 30, Monday morning 2 October, Michael Dale came in to 3F told me Walter, Jeff du Montelle (R*D director, CK VP of clinicals, and couple other were gone by 9 am. The clean up was done quickly. They spent the whole week here and left this noon, and we looked at all development issues. I think slowly (ti be desured) they will figure out that your ideas and Ludwigs were stolen by Bjarne. I did tell them that when Bjarne asked me how to do a percutaneous/transluminal valve with system <80 cm as we were granted by PVT /Anderson patent, I told him, three routes: subclavian like you guys had done before, infrarenal aorta as is possible surgically and lastly I said, do it like Huber has been doing since 2002 with valves we donated, but the idea was yours.

Then two months later in Jan 2004 he declared he had an idea for patent trans-apical trans-ventricular to Walter, Olav his father and chairman of board of 3F. A lot of engineers left after that because they knew they had made the valves for your use for over 2 years, and this guy claimed he invented it.

Please keep this confidential to protect me. Until they realize that he has really nothing. By the way, I brought the idea of a dog-bone balloon to keep valved-stent from excaping, told him about it and he included in his patent, although the day i brouhg the idea in, my most respected engineer in Nitinol and stents showed me 5 minutes later pictures from the web site that fabricated them already for a few years.

Anyway, eventually they (ATS) will figure out the fellow can not bring much to the plate.

Good luck. I will keep searching for a cheaper crimper. Are you coming to TCT or American heart?
