

The assigned examining attorney has reviewed the referenced application and determined the following.

### SEARCH RESULTS

The examining attorney has searched the Office records and has found no similar registered or pending mark which would bar registration under Trademark Act Section 2(d), 15 U.S.C. Section 1052(d). TMEP section 1105.01.

### **INFORMALITIES**

Before the application can be considered further, the following informal issues must be addressed.

### I. Identification of Goods/Services

The wording "including user documentation and other material sold with the computer programs and systems" in the identification of goods is unacceptable as indefinite. The applicant may amend this wording to "and instructional manuals sold as a unit," if accurate. TMEP section 804.

The wording "networked presentation systems" in the identification of goods is too broad because it could include items classified in other classes. The applicant must amend the identification to list each item by its common commercial name. TMEP sections 804 and 804.03.

In the identification, the applicant must use the common commercial names for the goods, be as complete and specific as possible and avoid the use of indefinite words and phrases. If the applicant chooses to use indefinite terms, such as "accessories," "components," "devices," "equipment," "materials," "parts," "systems" and "products," then those words must be followed by the word "namely" and the goods listed by their common commercial names. TMEP sections 804 and 804.08(c).

The wording "computer services. the operation" in the recitation of services is unacceptable as indefinite because it does not clearly define the service. The applicant must amend the recitation to specify the common commercial name of the services. If there is no common commercial name for the services, the applicant must describe the services and indicate their nature. TMEP section 1301.05. If the applicant has access to the world wide web, it is strongly recommended that it review the Office's searchable database of the Manual of Acceptable Identifications of Goods and Services. The wording "including training" in the recitation of services is unacceptable as indefinite. The applicant may amend this wording to "Computer education training services," if accurate TMEP section 1301.05. See Classification below.

In the identification, the applicant should use the common commercial designation for the services, be as complete and specific as possible and avoid the use of indefinite words and phrases. The applicant may not include broad wording such as "services in connection with..." or "such as" or "including" or "and like services" or "systems" or "products" or "concepts" or "not limited to...." - The Examining Attorney has objected to the identification of goods as indefinite and
