On March 6, 2017, Petitioner filed a motion for *Pro Hac Vice* Admission of John W. Harbin. Paper 11 (“Motion”).² The Motion is supported by a Declaration of Mr. Harbin. Ex. 1014.³ Patent Owner has not opposed the Motion.

Upon review of the record before us, we determine that the requirements of 37 C.F.R. § 42.10 have been met and there is good cause to admit Mr. Harbin *pro hac vice*.

It is, therefore,

ORDERED that Petitioner’s Motions for *Pro Hac Vice* admission of John W. Harbin is granted; Mr. Harbin is authorized to act as back-up counsel in the instant proceedings only;

FURTHER ORDERED that Petitioner is to continue to have a registered practitioner represent it as lead counsel for the instant proceedings;

FURTHER ORDERED that Mr. Harbin is to comply with the Office Patent Trial Practice Guide and the Board’s Rules of Practice for Trials, as set forth in Part 42 of Title 37, Code of Federal Regulations; and

FURTHER ORDERED that Mr. Harbin is to be subject to the Office’s disciplinary jurisdiction under 37 C.F.R. § 11.19(a), and the USPTO Rules of Professional Conduct set forth in 37 C.F.R. §§ 11.101 *et seq.*
