Pursuant to 37 CFR §42.20 and 35 U.S.C. § 317, Patent Owner PerdiemCo LLC ("Patent Owner") and Petitioners Teletrac Inc. and Navman Wireless North America, Ltd. (collectively "Teletrac") jointly and respectfully request the Board's permission to file a Joint Motion to Terminate in each of the following proceedings with respect to Teletrac only:

- IPR2016-01061 (U.S. Patent No. 8,223,012);
- IPR2016-01062 (U.S. Patent No. 8,493,207);
- IPR2016-01063 (U.S. Patent No. 8,717,166);
- IPR2016-01064 (U.S. Patent No. 9,003,499); and
- IPR2016-01278 (U.S. Patent No. 9,071,931).

The termination with respect to Teletrac is pursuant to a Settlement Agreement in which the parties have agreed to end their disputes in their district court litigation and the aforementioned proceedings.
