Petitioner proposes that the Board hold any further proceedings in abeyance until the time to petition the Supreme Court for a writ of certiorari has passed or until any such petition is resolved. In an order dated March 19, 2020, the Supreme Court extended the deadline to file any petition for a writ of certiorari to 150 days from the date of the lower court judgment.² In this case, the judgment in the appeal issued on September 4, 2020, and therefore the deadline to file a petition for a writ of certiorari is February 1, 2021.
